COMMENT:

On June 3, 2014, the City Council adopted Ordinance 1812, which established a five member Animal Control Commission to serve in an advisory capacity to the City Council on any matters concerning animal control. The ordinance provides that Commissioners be appointed by the City Council at its complete discretion by a majority vote. Commissioners shall serve 4-year staggered terms, shall be residents of the city of Porterville, and representative of a cross-section of the community.

For the establishment of the Animal Control Commission the Council shall appoint five members, two to 2-year terms and three to 4-year terms. After the initial establishment of the Commission, future members of the commission will be appointed to 4-year terms and will serve until his or her term is completed, or until such time that his or her appointment is rescinded by a majority vote of the City Council.


To Whom It May Concern,
