The City Manager introduced the item, and the Acting Community Development Director presented the staff report.

19. GOVERNOR'S EXECUTIVE ORDER FOR STATEWIDE MANDATORY WATER REDUCTIONS, AND THE PROVISION OF WATER TO EAST PORTERVILLE RESIDENTS

Recommendation:

That the City Council accept staff's report, and provide direction as

appropriate.

City Manager Lollis introduced the item and presented the staff report. Following the staff report he added that the State had informed the City that Del Oro Water System was under a no drink order.

- Andrew Lockman, Tulare County OES, stated that the City provision of water to the County via Mutual Aid Request would not hurt the City's water conservation numbers; and addressed questions from the Council regarding the status of the well project, the funding, and agreement.
- Chad Fischer, State Water Resources Control Board Division of Drinking Water, Tulare
 District Engineer, advised that the City contact the Assistant Deputy Director of the
 Financial Assistance Division at Water Resources Control and provided staff with his
 contact information; and stated that the City should complete an online FAST application
 for the Vandalia Street area.
- Joel Greathouse, Project Manager, State Water Resources Control Board Division of Financial Assistance spoke of funding resources and provided information regarding the online application process.

Acting Public Works Director Mike Reed spoke of the Vandalia area, efforts to survey residents, estimated costs for construction, and connection fees. It was corrected that the FAST application was not for grant funds.

The Council discussed the status of the new well, the Mutual Aid Request, and the continued provision of water; and expressed their shared frustration regarding the lack of forward movement with regard to the new well. They spoke of the importance of being able to provide for their current customers and the pending receipt of the water system study.

• Andrew Lockman, Tulare County OES, addressed questions from the Council regarding the amount of water being requested by the County.

In response to questions posed by the Council, Acting Public Works Director Mike Reed spoke of the status of the water system analysis, and stated that he was not comfortable with the City providing water to the County at that time. He expressed concern regarding the potential impact to the system, especially during the summer months, and planned development.

COUNCIL ACTION:

MOVED by Mayor Stowe, SECONDED by Council Member Gurrola that the City Council deny the Mutual Aid Request until an additional water source comes online; and direct staff to work the Porterville Area Coordinating Council regarding the Vandalia residents.
